FURTHERMORE, Council, with majority vote, will discuss and consider options for the appointing of a temporary Town Administrator as per Section 110.1(2) – if for any reason the Administrator is unable to act, a council shall appoint within 30 days after the administrator is unable to act to fill the position of Administrator of the municipality in an acting capacity - dates of temporary appointment from July 25, 2023 up to October 24, 2023 or sooner as determined by Town Council or a full-time Town Administrator is appointed;

FURTHERMORE, the temporary appointed Town Administrator shall only perform the duties and exercise the powers and functions assigned to an Administrator as per Sec. 110(3)(a) by the Municipalities Act and other Acts; and (b) those specified by the Town of Kamsack Council.

FURTHERMORE, Council will approve an interim hiring committee from July 24, 2023 to September 11, 2023, unless a full-time Town Administrator is appointed. The committee will consist of the Mayor Nancy Brunt and two Councilors, Lyle Romaniuk and Claire Bishop (with Councilor Jodi Sas as an alternate). This committee will review, interview and recommend qualified candidates for the following available positions with the Town of Kamsack – Assistant Town Administrator (out of scope); Temporary Administration Clerk I (as per CUPE Collective Agreement or as per Council); Public Works Manager (out of scope); and Water Treatment Manager (out of scope) and any other Town of Kamsack positions that become open within the interim hiring committee's time frame.

THEREFORE, Council ratifies the position of Town Administrator to be considered vacant and to be temporarily filled by the person Council, by majority vote, chooses for the time frame specified above and consider options presented to appoint a full-time Town Administrator at such time as an appropriate candidate is presented.

S001.1-23 THEREFORE, Council, by full recorded vote, appoint Sherise Fountain as temporary Town Administrator for the Town of Kamsack as per Sec. 110.1(2), effective July 25, 2023 to September 11, 2023, with extension as needed and approved by Council up to October 24, 2023 or when a full-time Administrator is appointed.

FURTHERMORE, temporarily appointed Town Administrator Sherise Fountain shall only perform the duties and exercise the powers and functions assigned to an Administrator as per Sec. 110(3)(a) by the Municipalities Act and other Acts; and (b) those specified by the Town of Kamsack Council which includes all required signing and approval authorities for the continued operations of the Town of
