

BYLAW No. 2024-09 UTILITY RATES BYLAW

A BYLAW OF THE TOWN OF KAMSACK TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF RENT OR SERVICE CHARGE FOR THE USE OF SEWER.

The Council of the Town of Kamsack in the Province of Saskatchewan enacts as follows:

Short Title

1. This bylaw shall be known as 'The Utility Rates Bylaw'.

Conversions

- 2. Conversions used in this bylaw are as follows:
 - -1 cubic foot = 6.2288 gallons (Imp.)
- -1 cubic meter = 35.315 cubic feet
- -1 cubic foot = 0.0283 cubic meters
- -1 cubic meter = 219.969 gallons (Imp.)
- 3. The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule "A" attached; provided however that the minimum shall be payable in every case whether or not any water is consumed.
- 4. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "B" attached.
- 5. Bylaw No. 29/2018 is hereby repealed.
- 6. The rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee or on July 20, 2024, whichever is the later.

SCHEDULE "A"

MONTHLY WATER RATES:

- 0 400 cubic feet a minimum charge of \$40.00 over 400 cubic feet @ \$7.00 per hundred cubic feet
- 0 11 cubic meters a minimum charge of \$40.00 over 11 cubic meters @ \$2.425 per cubic meter
- 1.3 0 2,500 gallons a minimum charge of \$40.00 over 2,500 gallons @ \$11.265 per 1,000 gallons
- **1.4** Assiniboine Rural Pipeline \$16.00 per 1,000 Imperial gallons

1.5 SERVICE FEES

Residential: \$75.00
Commercial: \$75.00
7-day permit (Cleaning purposes) \$125.00

• Reconnect Charge for non-payment \$125.00

• Disconnect/Reconnect Fee for repairs: \$75.00

\$125.00 on weekends

Connects and Disconnects only occur on Monday, Tuesday, Wednesdays or Thursdays providing there is no statutory holidays the next day except for emergency situations.

1.6 ACCOUNT DEPOSITS

Residential: \$180.00Commercial: \$180.00

1.6 FROZEN OR DAMAGED METERS

In the event of a meter being frozen or damage by the home owner, the following fees apply:

Under 2 inches \$250.00 plus GST
2 inches and over \$300.00 plus GST

SCHEDULE "B"

MONTHLY SEWER RATES:

- 1.1 0 400 cubic feet a minimum charge of \$20.00 over 400 cubic feet @ \$1.75 per hundred cubic feet of water used
- 0 11 cubic meters a minimum charge of \$20.00 over 11 cubic meters @ \$0.606 per cubic meter of water used
- 1.3 0 2,500 gallons a minimum charge of \$20.00 over 2,500 gallons @ \$2.682 per 1,000 gallons of water used
